

# Privacy Policy

**BabyAC: AI predicts the baby's face** (“we,” “our,” or “us”) is committed to protecting your privacy. We understand the importance of protecting your privacy. Therefore, we have established the Privacy Policy to explain how we treat your information and protect your privacy when you use this software (“Software”) and services this Software provides (“Service”) and the rights and options available to you regarding your information.

This Privacy Policy applies to our website, and its associated subdomains (collectively, our “Service”) alongside our application, BabyAC: AI predicts the baby's face. By accessing or using our Service, you signify that you have read, understood, and agree to our collection, storage, use, and disclosure of your personal information as described in this Privacy Policy and our Terms of Service. **If you do not agree with the terms and conditions set forth herein, please do not use this Software and Service.**

We reserve the right to modify the terms of this Privacy Policy regarding the updates of the Software. You can check the modified version of this Privacy Policy from the Software. You understand and agree that if you continuously use the Software after the date on which these terms have changed, we will treat your use as acceptance and compliance with the updated terms.

## Definitions and key terms

To help explain everything as clearly as possible in this Privacy Policy, any reference to any of these terms is strictly defined as:

- **Cookie:** A small amount of data created by a website and saved by your web browser. It is used to identify your browser, provide analytics, and remember information about you, such as your language preference or login information.
- **Company:** When the terms "Company", "we", "us" or "our" are used in this policy, it means BabyAC: AI predicts the baby's face, who is responsible for your information under this Privacy Policy.
- **Country:** BabyAC: AI predicts the baby's face - Where the owners/founders of the BabyAC are located, in this case, Japan
- **Customer:** BabyAC: AI predicts the baby's face - means the company, organization or individual that has signed up to use the Future Baby Generator to manage relationships with your consumers or service users.
- **Device:** Any device connected to the internet such as a phone, tablet, computer or any other device that can be used to visit Future Baby Generator and use the services.
- **IP address:** Every device connected to the Internet is assigned a number known as an Internet protocol (IP) address. It is a numeric label, such as 192.0.1.1, that is attached to a computer network that uses Internet Protocol for communication. An IP address can often be used to identify where a device connects to the Internet.

- **Personnel:** It refers to persons employed by BabyAC: AI predicts the baby's face or is contracted to serve on behalf of one of the parties.
- **Personal Data:** Any information that allows the identification or identification of a natural person - including a personal identification number - directly, indirectly or in connection with other information.
- **Service:** It means the service provided by Future Baby Generator in the relevant terms (if any) and as described on this platform.
- **Third-party service:** refers to advertisers, contest sponsors, promotional and marketing partners, and others who provide our content or whose products or services we think may be of interest to you.
- **Website:** BabyAC: AI predicts the baby's face. Accessible via this URL: <https://baby-ac.com>
- **You:** A person or organization registered with the BabyAC: AI predicts the baby's face to use the services.

## **1.0 The Information That We Collect and The Purposes for Which It is Collected**

There are two general categories of information we will process:

### **1.1 Information that You Submit**

To use some of the functionality of the Software, you may voluntarily permit us to access the camera or photo album to obtain photos on your mobile device. We access your camera and/or photo album only if you confirm your permission. When you use the Future Baby Face Generator in the Software, we will capture the position and shape of the six sense organs in the photos of your face, analyze the facial features information, and give feedback on the effect drawing or conclusion to you. For such photos, facial features information, effect drawing, conclusion, and feedback result, we will neither store nor share them with any third parties after analysis. Please do not require this Software to process content that may directly or indirectly disclose any personal information.

### **Collection and processing of your facial features information:**

When you use Baby Generator features of the Software to process your facial photos, we will analyze the Face Data, recognize the position and shape of the five sense organs, and gender in the photos, then process them, and feedback the special effect photos to you.

If you cease to consent or affirmatively revoke consent for our collection and processing of your facial features information, we will promptly cease all such collection and processing.

Due to the limited processing resources available on mobile devices, we use a cloud server to process these images. Images remain in the cloud for a limited period of 24 hours, after which all photos are deleted from the cloud.

### **The purposes we collect your facial features information:**

We capture the facial features information only for operating the features for processing facial photos and providing better special effect photos for you.

**Storage and sharing of your facial features information:**

For such facial photos, facial features information and special effect photos, we will neither store in our server nor share them with any third parties after processing.

**1.1.1 Permission to Access to the Storage.**

To ensure that you may save photos or cache information normally to your device, you may voluntarily grant us the permission to access to the storage of your device.

Our purpose in accessing the camera is to use the functionality of the camera to take pictures following our instructions.

Our aim to reach the photo album is to recognize the position and shape of your five sense organs by following your instructions in your chosen face photo.

**1.2 Automatically Processed Information**

We may use an SDK provided by a third party (such as "Adjust") to collect technical information from your browser or device when you visit our Service. This information may include the type, name and version of the operating system: (i) your configuration and settings of the Software and Services, the version of the Software and Services; (ii) ISP (Internet Service Provider), Internet protocol (IP) address, Media Access Control (MAC) address, anonymous user identifiers, device configuration and identifiers; (iii) Advertising ID; (iv) location; (v) Apple ID.

We may use third-party APIs (such as "In-App Purchases on Apple App Store Connect") to collect information about your subscription orders, such as purchase items, subscription duration, order status, and payment term. We do not collect and are not responsible for the collection or security of payment details. Payment information is processed and stored by third-party companies (such as Apple Inc.). These companies can be contacted through their websites. Before entering your payment details, we recommend that you read and familiarize yourself with the privacy policy of these third-party companies. Also, we may use the API provided by Apple to collect your current region and preferred language.

**Payment data:**

We may collect information about your subscription orders, such as purchase items, subscription time, order status, payment time. We do not collect and we are not responsible for the collection or security of payment details. Payment information is processed and stored using third-party companies (such as Apple, Google). These companies can be contacted through their websites. Before entering your personal payment details, we suggest that you read and become familiar with the privacy policy of these third party companies.

**2. Sharing Information with Third-Parties**

We will not share any information we collect except for the following events:

1. If we are required to disclose it by law, we may share the information with law enforcement or other authorities and any third party that may be required (for example, to detect, prevent or otherwise address fraud, security or technical issues; follow any legal process, subpoena, or government request, or to protect the rights, property, or personal safety of our users, their partners, or the general public).
2. If we go through a business transition, such as a merger or takeover, consolidation, change of control, restructuring, or sale of all or part of its assets, your information will be among the assets transferred.
3. We may share information with certain third parties (including but not limited to search engines, content providers, and ad networks and platforms) that provide various services (such as advertising, marketing, analytics, content and search) in connection with the software and service. We take appropriate measures to ensure that no individual user can be identified from the disclosure of such information, and we require that these third parties (i) keep the data secure and (ii) not misuse the data, and (iii) use data only by applicable data protection laws and this Privacy Policy.
4. We may also share non-personally identifiable information with our subsidiaries, affiliates and parent companies, but their use of such information must comply with applicable data protection laws and this Privacy Policy.

We may use third-party Service Providers to monitor and analyze the use of our application.

### **3. Information may be collected by Third-Party**

Certain Services may contain content that links to advertisements, websites, products, and other services provided by third parties on our Software (collectively, "Third Party Services"). Use of such Third Party Services is subject to their privacy policies. You will be aware that the use of Third Party Services may give these third parties the ability to access, collect, store and/or share both your personal and non personally identifiable information. To clarify, we do not review, endorse, monitor, support, warrant or represent such Third Party Services and your access to any Third Party Services is at your own risk. We are not responsible for the information contained and/or made available by your Applications, for your use or inability to use such Third Party Services. You expressly exempt us from any liability arising from your use of such Third Party Services. In addition, Third-Party advertising companies may collect or use your PII (excluding your name, address, email address or telephone number) when you use the Software or Service to provide customized advertising. ### **4. Transfer of Data**

Software and Services run over the Internet. We may store and process information in various parts of the world. We and third-party organizations that provide automated data processing technologies for the Software or our third-party advertising partners may transfer automatically processed information across borders and from your country or jurisdiction to other countries or jurisdictions around the world.

## **5. Security of Your Information**

The security of your information is our top priority and we take strict measures to protect data from unauthorized access, use, disclosure or destruction. We have implemented physical, technical and administrative security measures for the Services that comply with applicable laws and industry standards. For example, we use firewalls, encryption technology and Network access designed to protect against fraud and identity theft; Our data is stored only in centers that provide high-level security for user information. In addition, we protect the privacy of the user by trying to minimize the amount of sensitive data and PII. In addition, we demand appropriate contractual protection from our partners regarding the processing of user data. However, please note that no method of transferring or storing information over the Internet is completely secure. Accordingly, we cannot guarantee the absolute security of any information.

## **6. Cookies**

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyze web traffic or lets you know when you visit a particular site

BabyAC: AI predicts the baby's face uses "Cookies" to determine the areas of our website you visit. A cookie is a small piece of data stored by your web browser on your computer or mobile device. We use Cookies to improve the performance and functionality of our app, but they are not necessary for their use. However, without these cookies, certain functions such as videos may not be available, or you may need to enter your login information each time you visit the app, as we cannot remember your previous login. Most web browsers can be set to disable the use of Cookies. However, if you disable Cookies, you may not be able to access functions on our website correctly or at all. We never place Personally Identifiable Information in Cookies.

We use cookies for tracking session information and not stored on our side. All of your data is stored locally on your device.

## **7. Data Retention**

We retain the information we collect as described in this Privacy Policy as necessary for the provision of the Services, internal analytical purposes, or to comply with its legal obligations, resolve disputes and enforce agreements (e.g., settlement). The criteria used to determine the retention periods include: (i) how long the personal data is needed to provide the Services and operate the business; (ii) the type of personal data collected; and (iii) whether we are subject to a legal, contractual or similar obligation to retain the data (e.g., mandatory data retention laws, government orders to preserve data relevant to an investigation, or data that must be retained for litigation or disputes).

## **8. Your Data Rights**

You have the right to access, change, correct or delete any personal data that you may have collected. If you are in the EEA, you have the right (with limited exceptions) to (i) access your personal information and request its rectification or deletion; (ii) restrict or object to the processing of your personal information; and (iii) request a copy of your personal information in digital format.
